# **Concealed Carry Reminder**

As a reminder, concealed carry is permitted on chapter property by a holder of a Handgun Permit valid in Maryland. If concealing a firearm, it MUST REMAIN CONCEALED AT ALL TIMES! Unconcealing a firearm to use it at the pistol range is strictly forbidden. To practice at the range with a concealed firearm - off chapter property - it must be unloaded and placed in a closed or latched container. Additionally, Maryland law prohibits concealed carry in State Parks. Be aware of State Park / Chapter property boundaries.

# **January 2025 BOD Highlights**

The Board of Directors of IWLAR met on January 17, 2025 at 7:30 pm. This is a summary of the business items and major announcements at the meeting.

- There were several requests to use the Chapter House, Lake and pistol range for activities representatives of Seneca Valley TU, Girl Scout Troop 32604, and Seneca Creek Park DNR. All were approved. These items are now on the calendar.
- We have received an insurance proposal and instructed the agent to issue the policy. This policy covers our liability, structure and marine needs. The cost will be \$22,121, a decline of \$1,686 from our 2024 policy. The decline is due to a revaluation of the replacement cost of the structures on our property. We hired a certified appraiser to provide us with current replacement value estimates, which were lower than the previous insurance company estimates.
- Wood duck box maintenance and repair is ongoing every Sunday. Watch the google group for notices.
- The next road cleanup is on February 9.
- We need additional members to serve as Eagle Scout Project Coordinators.
- Special thanks to Chris Holler for the snow removal effort around the Chapter House.
- The construction on the lake project is complete but the planting of trees and shrubs is still being planned (waiting on the County) and now the ground is frozen. We will get them planted sometime this spring.
- We approved an energy audit of the caretaker's house to determine if there is potential for energy (and cost) savings.
- The Chapter has contracted for a new security system to replace the outdated current system. The new system will give us coverage of the rifle house and audio capability at select locations.
- The By-Laws review is progressing and will be going to the membership sometime in the spring.

# Fence Maintenance Volunteers Needed

Winter winds and ice usually damage sections of the perimeter fence that encircles the pistol and rifle ranges. A few volunteers are needed for a work party on Saturday, February 22 at 11:00 AM, to walk and inspect the perimeter fence, clear any downed tree limbs on fence sections, and perform some light pruning to keep the walk path along the fence navigable. Bring work gloves, pruning shears, small saws, and hearing protection for areas close to the firing lines. We'll have a battery chainsaw. A good opportunity to get 2-3 volunteer hours completed early in the year! Please reply directly to Duval Crist if you're interested and available.

## **Cases on the Ranges**

As a reminder, the Range Rules require all firearms carried on Chapter property must be unloaded and carried in a closed or latched container (see Range Rules page 4). A firearm case completely encloses the firearm and latches, snaps, or zippers completely shut. A holster or other articles (such as shirts, rags, blankets, etc.) wrapped around firearms are not considered cases. If firearms are carried without proper cases, they must be in an enclosed container that completely shuts, such as a range bag. When removing an uncased firearm from an enclosed container (only at the shooting position, pointing down range), the firearm must immediately be made SAFE. When transporting firearms in hard cases that don't correspond to the general firearm shape, a good practice is to apply a strip of masking tape to the outside and draw an arrow with the word "muzzle" on the strip. This will go a long way in preventing firearms from not pointing downrange when the case is opened.
