He came to WSSC from Montgomery County Government in Maryland, where he held the positions of Assistant Chief Administrative Officer, Office of Management and Budget Director and Finance Director. A graduate of the University of Michigan, Mr. Beach also holds a Master of Arts Degree in Public Affairs from the George Washington University and a J.D. from the University of Baltimore. Mr. Beach serves on the Board of Investment Trustees for the Montgomery County Employees Retirement System and the Consolidated Retiree Health Benefits Fund and is the Past-President of the Maryland Government Finance Officers Association.
