MD Wear and Carry Permit Training

The Rockville Chapter conducted its first MD Wear and Carry Permit Training class on August 12, 2022, attended by Jacob Song, David Baker, Jake Soffronoff, Jun Lu, and Pete Lee with volunteer NRA Certified and MD State Police Qualified Handgun Instructors Jose Cabrita and Rich Clement.



MD Wear and Carry Permit Training consists of 16 hours of instruction for an original application and includes instruction on MD Firearms Law, home firearm safety, handgun mechanisms and operation, and a component that requires the applicant to demonstrate gun safety and shooting qualification proficiency with a minimum score of 70% accuracy. MD Wear and Carry Permit Training is offered after successful completion of the Chapter's NRA Basics of Pistol Shooting Course with the MD Handgun Qualification License Supplement to satisfy the balance of prerequisite instruction and shooting qualification required to apply for the MD Wear and Carry Permit. The Jr. BB gun class is open to children ages 8-15. It meets most Tuesday evenings from 7-9 pm and continues until May. The orientation for NEW BB gun students will be Tuesday, Sept. 27 at 7:00 pm. Parents should plan to attend the first meeting. The fee is \$45 for members and \$50 for non-members. The first regular practice will be October 4th.

The Jr. Air Rifle class is open to children ages 12 - 18. It meets most Saturday mornings from 9 - 11 am and continues until May. The orientation for NEW students will be Saturday, Sept. 17th at 9 am. The fee for members is \$50 and for non-members is \$55. The first regular practice will be on Oct. 1st.

For both classes, the Chapter provides all the equipment. Students need only bring eye protection (ear protection optional)

Volunteers are needed to cook throughout the year. Pick a month and get your six volunteer hours in one night. For more information contact Jeri Crist.


