July Speaker Focus

Robbie Deibert will be speaking about the Blohm Park Stormwater Pond Improvements, located in the City of Gaithersburg. Robbie, PMP, ENV SP, is a Senior Project Engineer with a strong background in stormwater management. He brings expertise in sustainable infrastructure implementation, flood mitigation, and regulatory compliance, with a strong emphasis on resilient water resource solutions. As a certified Project Management Professional and Envision Sustainability Professional, he combines technical knowledge with a strategic approach to project delivery, ensuring environmentally responsible and cost-effective outcomes.



Robbie has lived in Montgomery County for 10 years. He has been a member of the Chesapeake Water Environment Association (CWEA) serving on the Phase II MS4 stormwater committee and the Metropolitan Washington Council of Governments (MWCOC) Water Resources Technical Committee for 5 years. Robbie enjoys spending free time hunting and fishing while making frequent trips to his cabin near the Pennsylvania Gorge.

The Blohm Park Stormwater Pond Improvement project proposes to remove approximately 1500 CY of sediment from the basin, restore the vegetative shoreline, and stabilize dam embankment. The primary purpose is to restore pond capacity, improve function, and support water quality. Preventative maintenance of this nature will maintain long-term effectiveness of stormwater infrastructure. Discussion topics will include information on a completed feasibility study, current project status, and proposed design and construction activities.

Make Your Voice Heard!

The national Izaak Walton Convention is coming in mid-July. At this annual event, there is an opportunity for members to offer changes to the policies of the organization. This year there is a new resolution offered that would urge federal authorities to establish national standards for data centers and similarly high energy consuming and producing facilities to ensure that future facilities approvals include more local control and a greater recognition of the water and energy used by these facilities.

A data center is a physical structure that contains many computer servers which process an extremely large volume of highly sensitive data. They consume an enormous amount of power, land, water, and emit CO₂, noise from Electromagnetic Fields, Low Frequency Noise, and contribute to electronic waste. The data center industry is sprawling across small towns specifically because of expected growth in Artificial Intelligence. There are very few, if any, regulations on the Data Center Industry.

You as members of the Rockville Izak Walton League have an opportunity to express your views on this issue. The Rockville Chapter has 7 votes, and it is up to you—the members to decide how those votes are cast. To determine where you stand, we have established a poll that was sent via google group about the June 21 or 22-time frame. If you registered your opinion then, thank you. Ron is our longtime, award-winning American chestnut guy.
